Narrative:

(8) [REDACTED] and [REDACTED] used to be married and reside at the listed residence. [REDACTED] and [REDACTED] divorce was recently finalized. [REDACTED] is [REDACTED] step-father.

Today, [REDACTED] went to [REDACTED] residence to collect some belongings. [REDACTED] went with her to assist. While [REDACTED] was inside the residence [REDACTED] and [REDACTED] got into a verbal argument regarding the tax paperwork. According to [REDACTED], she was holding the tax paperwork when [REDACTED] grabbed her right hand and squeezed it, causing pain. [REDACTED] dropped the paperwork and as she reached for it, [REDACTED] grabbed her right arm and again squeezed it, which caused pain. [REDACTED] then picked up [REDACTED] cell phone and stated that she was calling the police to help her get her "stuff". [REDACTED] stated that [REDACTED] grabbed the phone from her then grabbed onto her arm and drug her out of the house. [REDACTED] then went outside and called 911 from her cell phone.

I arrived with Deputy Didway. I spoke to [REDACTED] as Deputy Didway spoke with [REDACTED]. [REDACTED] gave me the above verbal statement. [REDACTED] also stated to me that when [REDACTED] grabbed her wrist, he twisted it. [REDACTED] did not provide that information to Deputy Didway as he took her written statement. I could see some minor reddening on [REDACTED] upper arm. I went inside and listened as [REDACTED] spoke to Deputy Didway. I heard [REDACTED] state that he never grabbed [REDACTED]. Based on the information provided by [REDACTED] and the allegation of an assault, I took [REDACTED] into custody for Assault 4 and Interfering with the Reporting of Domestic Violence. I read [REDACTED] his Miranda Rights from my department issued card. I asked [REDACTED] if he understood his rights and he told me "yes."

I took [REDACTED] out to my patrol car where I asked him if he wanted to provide a written statement or wait to speak to an attorney. [REDACTED] stated "yes I'll give you a statement." I took a typed statement from [REDACTED] where he stated that he only grabbed the tax paperwork from [REDACTED] because she was about to rip it. He stated that he was standing behind her, reached around her with his right arm, and took it from her. He stated that he never grabbed onto her and that any contact was incidental. He stated that he took the phone away from [REDACTED] only after he told her to give it back and she refused, and that again, any contact was incidental. Again, [REDACTED] stated that at no point did he grab onto [REDACTED] or twist her wrist.

I gathered [REDACTED] cell phone from inside the residence at his request. I checked the most recent dialed number, which was 911. I asked [REDACTED] if he called 911 from his cell and he stated that he might have when [REDACTED] would not leave.

Deputy Didway took a written statement from [REDACTED], completed the DV Supplemental and provided her with a DVPA. Deputy Didway also took photos of [REDACTED] and transported [REDACTED] to Precinct 3 to await transport to KCJ.

Sgt. Corey responded to the scene and spoke shortly to [REDACTED]. He also contacted the King County Jail Commander, Capt. Bacon, at 1400 hours and advised of [REDACTED] impending booking.

I took a typed statement from [REDACTED]. I also completed the Explanation of Rights Form which [REDACTED] signed. I took the film from Deputy Didway and submitted it for processing at Precinct 3.

I also took a typed statement from [REDACTED]. He stated that he was outside when her heard [REDACTED] call out to him in a "frantic" voice. He stated that when he got to the front doorway, he saw [REDACTED] holding onto [REDACTED] arm and was trying to pull her out of the house. He told [REDACTED] to stop, which he did.

While at Precinct 3, we were advised that [REDACTED] attorney, Duncan Wilson was on his way to the precinct and requested we advise [REDACTED] not to answer any questions. Deputy Didway called Mr. Wilson and advised him that [REDACTED] had already given a statement and that he would be leaving for KCJ shortly. Mr. Wilson did not arrive at the precinct before I completed this report.

Deputy Meeks transported [REDACTED] from Precinct 3 and booked him into KCJ.

This case is forwarded to the Covington Prosecutor with the recommendation that [REDACTED] be charged with one (1) count of Assault 4 (9A.36.041) and one (1) count of Interfering With Reporting of Domestic Violence (9A.36.150.)
