Dear Yale:

In response to yours of March 22<sup>nd</sup>, the City has received and reviewed the documents of the Spokane Downtown Foundation, Preston Gates & Ellis, Walker Parking, the Business Improvement District and the Downtown Spokane Partnership. Subpoenas are outstanding to Prudential Securities, Foster Pepper, The Compass Group and Robinson Research. I am told the Developers will move for a protective order relative to some of the documents to which our subpoenas are directed. We will resist.

We have conferred with the Developers relative to their discovery and received their objections and responses. They have proposed a stipulated protective order that we have rejected. Having fulfilled our LR 37 requirements, we have told them we will move to compel this week. We have scheduled a LR 37 conference with Pete Vial relative to Robideaux's production.

There is nothing that Messrs. Connor, Shook and Grant have developed that is more germane, significant and focused than the materials we have been collecting. I can assure you that the developers are more concerned about our efforts than they are with the efforts of the investigative reporters.
